Liability Exclusion: The safety of a boat and her entire management including insurance shall be the sole responsibility of the competitor/person in charge. Neither this notice nor any inspection of the boat limits or reduces the absolute responsibility of the competitor/person in charge for their crew, the boat and her management. The event organisers shall not be liable for any loss, damage, death or personal injury howsoever caused to the competitor/person in charge, or crew or accompanying persons, as a result of their taking part in the event and races and the competitor/person in charge indemnifies the event organisers against all and any costs, claims, demands and liabilities in respect of the same.
